Following SAGF issuing of suggested Honorarium and travel rates, we are aligning our WCGA rates to those suggested by SAGF:

Director of Judging – Depending on Level - use applicable Judges rate	

*If judges are being used as scribes, they will receive the amount applicable to their judging qualification.

- ❖ Please note that Judges are expected to have their own flashcards and to adhere to the prescribed dresscode.
- ❖ All Judges are expected to abide by the Judges Oath and relevant code.

- ❖ Clubs entering competitions with 5 or more gymnasts will have to provide at least 1 judge (discipline dependent) in order for their gymnasts to be allowed to compete. All entries of judges and gymnasts must be done online via the SAGF registration system.
- ❖ By entering gymnasts into any competition, the club is indicating that it has a current, valid and signed indemnity form for every gymnast being entered. It is also indicating that it agrees to the code of conduct issued by SAGF (SAGF Rules and Regulations - Annexure J Code of Conduct for SAGF members) applicable to gymnasts/coaches/judges/technical officials that it is entering and that the gymnasts/coaches/judges/technical officials will abide by the code.
- ❖ Please note that entry fees are not refundable after the closing date. The Western Cape Gymnastics Board will consider exceptional circumstances, provided that these are done in writing and accompanied by proof as requested by the board. There will be an admin fee of R50 per refund as changes will have to be made to the listings/groupings and to cover the cost of the refund (bank charges/handling fee etc).
- ❖ However, if Western Cape Gymnastics refunds a gymnast, then the gymnast will not be able to compete again in any Western Cape Competitions in the current year. If someone is injured and going to be ready to compete again at a later stage, then they forfeit the entry fee (they would have competed and want to keep their options open)
- ❖ Kindly note that gymnasts who are injured or sick and are unable to compete, must hand in a doctors note before the competition or at the very latest at the competition to the District or Provincial Program Manager, in order for the refund to be considered.
- ❖ Please see below the minimum qualification required to be on the competition floor as a coach or judge at competitions:
