JUDGES	All Clubs entering need to supply the following amount of Judges:     1 - 10 Gymnasts: 1 Judge     11 - 20 Gymnasts: 2 Judges     21 - 30 Gymnasts: 3 Judges     31 Gymnasts or more: 4 Judges  Alternatively you will be liable for a PROXY FEE of R 500.00 per Judge for the Competition, payable by the Closing Date with the Gymnasts Entry Fees  Once all entries have been received, Clubs will be billed for their proxy fees separately as this cannot be done online  Entry fees will only be considered paid once proxy fees have been paid
