Dear Western Cape Clubs, Coaches and Officials

Level 1 – 3 District Trials (2nd Trial Competition)

In our effort to ensure that our novice levels are exposed to additional competitions and keeping in line with the SAGF LTPD, the Western Cape Gymnastics Board has decided to include a 2nd district trial competition for level 1-3 gymnasts to allow these gymnasts an opportunity to qualify for the South Zone Championships. This competition will be held with the level 4-6/7 WAG-MAG competition on July 31/August 1.

Please note this is not a compulsory competition however it is in our efforts to ensure that we make this competition available to those who wish to attend.

It was decided by the board that as the South Zone trials were held 2 months prior to the South Zone Championships, and in line with allowing maximum participation at the Championship, we will allow the gymnasts who either missed the Level 1-3 district competition or those competitors who were unsuccessful in achieving the qualifying score at the first trial event, the opportunity to take part in this competition and essentially have a second chance to qualify for the South Zone Championships.

We feel this is a positive step in aligning with the senior levels and allows the gymnasts another chance at being successful. The main drive for this is the campaign to keep gymnasts in our sport and by allowing them a second chance will move us forward in delivering our core goals.

Please note as mentioned competition participation is at the clubs discretion completely and is not a requirement. It is merely another chance to allow our novice levels to compete in more competitions and also allow the selected few a second chance.

Please note that Artistic Gymnastics is considered the 1st Discipline for Multi-disciplining Gymnasts

Please note that all entries (for gymnasts, judges and coaches) will close at 5pm on 17 July and no late entries OR CHANGES will be able to be done after this. Please ensure that all forms are filled in correctly and that **coaches** and **judges names** are sent in at the same time as the entries! Gymnasts must be registered with SAGF. Entries will only be accepted if they are on the official entry form AND they are accompanied by the **deposit** form AND **proof of payment**

LATE ENTRIES OR CHANGES WILL NOT BE ACCEPTED. The entry fee is not refundable after the entry date. **If a club enters and does not pay, they are responsible for the full amount owing, regardless of whether the person/gymnast attended/ participated/competed or not.**

All clubs entering need to supply judges: Alternatively you will be liable for a **PROXY FEE of R500 per judge** for the competition payable by closing date with the gymnast's entry fees.

Each club competing will need to supply 1-2 (take turns) volunteers per day to help out.

Only qualified, registered & entered coaches/judges/volunteers will be allowed on the floor. They will be served meals as well as refreshments. Please ensure their names are listed on the entry form so that they can be catered for.
