- No unqualified Coaches/Judges will be allowed on the floor.

### JUDGES

All Clubs entering need to supply the following amount of Judges:

- 1 - 10 Gymnasts: 1 Judge
- 11 - 20 Gymnasts: 2 Judges
- 21 - 30 Gymnasts: 3 Judges
- 31 Gymnasts or more: 4 Judges

Alternatively you will be liable for a PROXY FEE of R 500.00 per Judge for the Competition, payable by the Closing Date with the Gymnasts Entry Fees

Entry fees will only be considered paid once proxy fees have been paid.
