Please ensure that all forms are filled in correctly and that **coaches** and **judges names** are sent in at the same time as the entries! Entries will only be accepted if they are on the official entry form AND they are accompanied by the **deposit** form AND **proof of payment**.

**LATE ENTRIES WILL NOT BE ACCEPTED.** The entry fee is not refundable after the entry date. **If a club enters and does not pay, they are responsible for the full amount owing on the entry form, regardless of whether the person/gymnast attended/participated/competed or not.**

All clubs entering need to supply judges:

Alternatively you will be liable for a **PROXY FEE of R500 per judge** for each of the competitions (Trampoline and Tumbling), payable by closing date with the gymnast's entry fees.

**Each club competing will need to supply 1-2 (take turns) volunteers per day to help out.**

All registered officials (judges & coaches) will be served meals as well as refreshments. Please ensure their names are listed on the entry form so that they can be catered for.
